the twelve steps of alcoholics anonymous

1. We admitted we were powerless over alcohol—that our lives had become unmanageable.
2. Came to believe that a Power greater than ourselves could restore us to sanity.
3. Made a decision to turn our will and our lives over to the care of God as we understood Him.
4. Made a searching and fearless moral inventory of ourselves.
5. Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.
6. Were entirely ready to have God remove all these defects of character.
7. Humbly asked Him to remove our shortcomings.
8. Made a list of all persons we had harmed, and became willing to make amends to them all.
9. Made direct amends to such people wherever possible, except when to do so would injure them or others.
10. Continued to take personal inventory and when we were wrong promptly admitted it.
11. Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out.
12. Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.

the twelve traditions of alcoholics anonymous

1. Our common welfare should come first; personal recovery depends upon A.A. unity.
2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.
3. The only requirement for A.A. membership is a desire to stop drinking.
4. Each group should be autonomous except in matters affecting other groups or A.A. as a whole.
5. Each group has but one primary purpose—to carry its message to the alcoholic who still suffers.
6. An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose.
7. Every A.A. group ought to be fully self-supporting, declining outside contributions.
8. Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers.
9. A.A., as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.
10. Alcoholics Anonymous has no opinion on outside issues; hence the A.A. name ought never be drawn into public controversy.
11. Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films.
12. Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles before personalities.

Alcoholics Anonymous, COVID-19 and Our Seventh Tradition

June 19, 2020

Dear A.A. friends,

We in A.A. – here at G.S.O., along with the rest of the world – continue to experience an unprecedented situation. Without question, due to the COVID-19 pandemic, our Fellowship, including our organized service structure, is facing enormous challenges, locally and globally. For many of us, the most prominent example is that, for the first time in the 85-year history of our Fellowship, we are navigating the lack of face-to-face meetings. While we have found creative ways to allow for the vital interaction between one alcoholic and another, and welcoming newcomers daily, it is clear that the health crisis has other far-reaching consequences.

As we all adapt to the present reality of digital meetings, the question now is, “How do we responsibly practice self-support, our Seventh Tradition?” As we can no longer pass a physical basket, we are working to find ways to support the Fellowship at all levels, from our groups to Intergroups and Central Offices, from our Districts and Areas to the General Service Office itself.

The reality is that even though meetings, Twelfth Step services and operations have shifted to a virtual environment, expenses continue to accumulate during this crisis, which underscores the importance of practicing the Seventh Tradition. Through this crisis, however, we have witnessed the many ways in which the entire A.A. Fellowship has come together to provide ongoing support. Among them:

- Many home groups are still paying rent even though their meetings cannot convene. They are also providing online meetings on platforms that may have associated costs.
- Intergroup/Central Offices are still stocking needed literature and fielding Twelfth Step calls, redirecting A.A. members and those looking for recovery to online meetings.
- Area-level committees are working to keep channels open between the Fellowship and the delegates and board members that make up our General Service Conference, as well as to do public information, corrections and other service.
- G.S.O. in New York is continuing to support all levels of service. Literature still needs to be published and distributed, calls need to be answered, online platforms still need to be updated, and support operations sustained.

In an effort to keep the membership informed during this challenging time we would like to share a brief three-minute video update from Leslie Backus, the Class A (nonalcoholic) treasurer of our General Service Board.

Alcohólicos Anónimos, COVID-19 y nuestra Séptima Tradición

19 de junio de 2020

Queridos compañeros de A.A.:

Nosotros los miembros de A.A. —tanto aquí en la OSG como en el resto del mundo— seguimos pasando por una experiencia sin precedente. Sin lugar a dudas, debido a la pandemia de COVID-19, nuestra Comunidad, incluida nuestra estructura de servicio organizada, se ve enfrentada a un imponente desafío, a nivel local y global. Para muchos de nosotros, el ejemplo más claro es que, por primera vez en los ochenta y cinco años de la historia de nuestra Comunidad, nos estamos esforzando por lidiar con la falta de reuniones cara-a-cara. Si bien hemos encontrado otras formas creativas para facilitar la interacción vital entre un alcohólico y otro, y estamos acogiendo a principiantes cada día, no obstante es incontrovertible que la crisis de la salud ha tenido otras consecuencias de gran envergadura.

Al irnos adaptando a la realidad actual de las reuniones digitales, la pregunta que se nos plantea es: “¿Cómo podemos poner en práctica el automantenimiento, nuestra Séptima Tradición, de manera responsable?” Visto que ya no podemos pasar la canasta física, nos estamos esforzando por encontrar formas de apoyar a nuestra Comunidad a todos los niveles, desde los grupos e intergrupos y oficinas centrales hasta nuestros distritos y áreas y la Oficina de Servicios Generales.

La realidad que tenemos que reconocer es que, si bien las reuniones, servicios de Paso Doce y operaciones han cambiado a un entorno virtual, los gastos se siguen acumulando durante esta crisis, lo cual recalca la importancia de poner la Séptima Tradición en práctica. Durante esta crisis, hemos visto las múltiples maneras en que la Comunidad se ha unido para dar un constante apoyo:

- Muchos grupos base siguen pagando su alquiler aunque no se puedan celebrar las reuniones en las salas. También están realizando reuniones en línea en plataformas que pueden suponer gastos adicionales.
- Las Oficinas Centrales/Intergrupos todavía tienen almacenada la literatura que se necesita y siguen atendiendo a las llamadas de Paso Doce y dirigiendo a las reuniones en línea a los miembros de A.A. y a los que buscan la recuperación.
- Los comités a nivel de área se siguen esforzando por mantener abiertos los canales entre los delegados y los miembros de la junta que componen la Conferencia de Servicios Generales, realizan los trabajos de servicio de información pública, correccionales y otros.
- La OSG en Nueva York sigue apoyando los servicios a todo nivel. Aún tenemos que publicar y distribuir nuestra literatura, responder a las consultas, actualizar las plataformas en línea, y sostener nuestras operaciones.

Con miras a mantener a los miembros informados durante estos días desafiantes, nos gustaría compartir con ustedes un corto video de tres minutos de duración por Leslie Backus, custodio Clase A (no alcohólica), tesorera de nuestra Junta de Servicios Generales, que nos ofrece una breve actualización de la situación.

While this was a difficult decision, and a disappointing outcome for those planning to attend, we are confident it was the most appropriate action to ensure the health and safety of our members. There is good news, however, as we now have an opportunity to bring together many of the special components that make International Conventions memorable — by utilizing a virtual platform. For this purpose, we are planning a 2020 International Convention digital site. Overview

All Area 25 AA members are welcome to attend the Area 25 Assembly. The assembly will be hosted online using the Zoom video conferencing platform and PC, Mac, and Apple/Android devices are all supported for the full conference experience, as well as just dialing in via a traditional telephone for an audio only experience. Each voting member will be required to use a Mac, PC, or Android/Apple device to vote during the closed business meeting at 2:00 p.m. on Saturday. Non-voting observers will be required to disconnect from the meeting and dial-in via a telephone to listen to the closed business meeting. This is necessary in order to prevent them from being able to vote.

Training Sessions

Two training sessions will be available for the Zoom videoconferencing platform at the times listed below. Information on devices supported, how to join the meetings, how to rename yourself, how to raise your “virtual hand”, how to use chat, voting, and other tips and tricks will be covered. These are all important features you will need to be familiar with for the conference. The two training sessions are scheduled as follows:

Virtual Conference Rooms

All assembly events will happen in the “Main” virtual conference room except for the committee meetings on Saturday morning, which will each have their own virtual conference rooms. Please note that each committee meeting room will have a different Zoom meeting link that you will need to click on in order to join. The links to all of the virtual conference rooms will be posted on the Area Assembly web page at <https://ks-aa.org/event/assembly/>.

Attendee Naming Convention

After joining a meeting, you will need to change your display name to the special format below by doing the following:

Mac/PC – Click on Participants at the bottom of your Zoom screen to bring up the “Participants” window. Now find your name in the Participants window (should be at the top of the list) and click on More > next to your name then click Rename.

Android/Apple – Tap your screen anywhere to show the button bar at the bottom and then click on Participants. Now find your current screen name (should be at the top of the list) and click on it and then select Rename. Note: If you see Safe Driving Mode on your screen, swipe left on your screen to get back to the normal meeting view and repeat the instructions above.

The participant naming format is as follows:

<Abbreviated District # or Area 25> - <Position> – <First Name and Last Initial>

Here are some examples:

D23 – GSR – Fred R.

D08 – DCM – Mary J.

D12 – Non-Voting – Allan L.

A25 – Delegate – Bill W.

A25 – Web Chair – Sam J.

A25 – Past Delegate – Joe M.

Raising Your Virtual Hand

In order to get the attention of the moderator for asking questions, making motions, etc., you will be required to raise your “virtual hand”. This displays a graphic of a hand next to your name in the participants list and in the top corner of your video tile. Here are instructions for raising your virtual hand:

Mac/PC - Click on Participants at the bottom of your Zoom window to bring up the “Participants” window. Once you have the “Participants” window open, click “Raise Hand” at the bottom to raise your virtual hand.

Android/Apple – Tap your screen anywhere to show the button bar at the bottom and then click on Participants. Now click on the picture of a hand that says raise hand on the bottom left. Then click Close to return to the normal meeting view. Note: If you see Safe Driving Mode on your screen, swipe left on your screen to get back to the normal meeting view and repeat the instructions above.

Now that your virtual hand is raised a moderator will know to call on you. You can lower your hand as well via the same button.
